### Board Position Summary

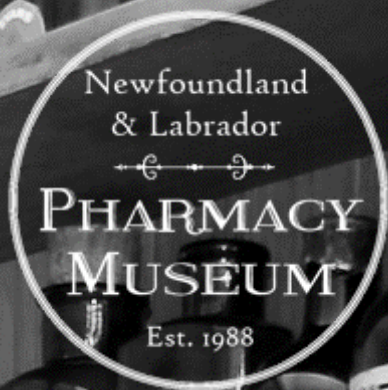
The Board of Director positions are *volunteer*-based and will work in a collaborative environment to provide the Museum Manager with oversight and direction for the daily operations of the Newfoundland & Labrador Pharmacy Museum. The Board will be comprised of arts/museum/tourism professionals, retired or active pharmacy professionals, and other professionals with experience in, but not limited to, fundraising, financial management, human resources, administration, event planning, technical expertise, and risk management.

The Board will meet once every 6-8 weeks for the first year of establishment. The schedule for meetings thereafter will be evaluated and determined at the Annual General Meeting. The Board will establish sub-committees as needed to support their mandate.

### Benefits

Serving on the Board provides its directors the opportunity to:

- Connect with dedicated professionals.
- Build relationships and develop networks.
- Gain an understanding of what is required to create a sustainable board e.g., financials, policies, best practices.
- Learn about the history of pharmacy and healthcare in the province.

### Eligibility

- Must be at least 19 years of age to fulfill a Board of Director position.
- Must be a resident of Newfoundland and Labrador.

### Term

- Board terms are for a period of either 2 or 3 years and will be re-assigned at the Annual General Meeting that follows the 2- or 3-year term.

### Board Composition

- The Board of Directors will consist of a minimum of 7 and maximum of 13 members.
- The officers of the Board will be comprised of 1 President, 1 Vice-President, 1 Secretary, 1 Treasurer, and a maximum of 9 Directors At-Large.
- Every effort will be made to seek out representatives that display and identify the background, skills, knowledge, and expertise needed to complement a well-rounded, fully functioning Board.
- The Board will play a critical role in creating an atmosphere that supports and invests in diversity, inclusion, and equity.
